**Facility Information:** USTA Billie Jean King National Tennis Center, Flushing Meadows, Queens. Showers and lockers are available, water will be provided to each player as well as available on the courts.

**Due to the major renovations going on at the NTC, including the addition of a new stadium, court availability is extremely limited and this will be an indoor tournament. Draw sizes may need to be limited and we may need to modify the scoring as well. In addition, matches may be randomly assigned to whichever the next available court may be.**

**Directions:** Take the #7 train to Willets Point/Shea Stadium in Queens and follow the boardwalk to the National Tennis Center. Visit <http://travel.mtanyct.info/serviceadvisory> (MTA website) for updated service advisories. Call the USTA NTC at 718.760.6200 for driving directions.

**Confirmation:** An e-mail confirmation (or phone call) will be sent within 48 hours of receipt of application. A final confirmation letter, with tournament details, will be sent the evening of May 23<sup>rd</sup>. Play begins at 8:00 a.m. on May 28<sup>th</sup>.

**Seeding:** Seeding will be determined using current GLTA rankings. All players must have a current USTA or MTG rating to play this tournament. If you do not have a current rating, you will need to attend one of our monthly events at which there will be a rater.

**Draws:** Registration closed May 18, 2016; refunds will not be given after May 18, 2016.

**Schedule:** Tournament officials will make every effort to notify players of scheduled match times. Players are responsible for knowing these match times. Please contact the tournament desk if you have a last-minute problem.

**Consolation Matches:** Consolation play for first match singles losers will be available. The format is an 8-game pro set, no-ad scoring, for all rounds except for the Final, which will be a best 2-out-of-3 sets. It is the player's responsibility for knowing the start times.

**Cancellations:** The tournament directors may combine or cancel divisions if less than four (4) players or teams sign up for a division. Entrants in a division being combined will be offered a refund if they choose not to play in the new division.

**Conditioning:** Please be advised that if you enter more than one event, you will be required to play multiple matches with minimal resting time between matches. Please consult with a physician if you feel you are at risk of heat or physical exhaustion, as MTG cannot be held responsible for injuries.
